NGA May Forum Looks at Making America 'Elder-Ready'

By the National Governor's Association (NGA)

America is getting older. Are we ready? As the nation's baby boomers begin to retire, the nation's governors are looking for public policies that will encourage healthier lifestyles, increase retirement planning, improve long term care, and utilize technology to enhance lifelong quality of life. Looking to make wellness the rule rather than the exception, NGA's Center for Best Practices will sponsor a two-day policy academy on the states role in aging in May, National Older American's Month.

Currently there are 35 million Americans 65 years of age and older. In eight years, that number more than doubles as 77 million baby boomers reach retirement age. While the numbers alone are staggering, the implications for government – from the federal to the local level – are daunting. Policy- makers and government officials must egin to plan for the large number of Americans who will require housing, health care, transportation and a myriad of government services.

With this in mind, Idaho Governor Dirk Kempthorne has made confronting America's long-term care challenges his top priority during his tenure as NGA Chairman. Since launching his Chairman's Initiative, "A Lifetime of Health and Dignity", Governor Kempthorne has traversed the country talking with aging experts, health care providers, academics, caregivers and seniors.

In May – National Older Americans Month – the NGA Center for Best Practices will host a policy forum in Chicago, as part of Governor Kempthorne's initiative, where high-level state teams will hear from national experts, and fellow governors, to begin developing a framework for addressing the pressing long-term care and aging challenges facing states. Temas from all 50 states and the U.S. Territories are invited to take part in the two-day best practices academy.

Following the discussion, the teams will be charged with developing action plans to implement policy changes at the state level that can help individuals live long and robust lives. Academy participants may focus on one of four policy objectives: Health and Wellness; Retirement Planning; Community Care and Caregivers; and In-Home Workforce.

Today and in the future, it is important for Americans to have the ability and opportunity to retire in communities they already call home while living active, independent lives, free from the burdens of illness and chronic disease. "Today, unfortunately, many Americans are not meeting their goal of aging with the well-being and way of life they desire", Governor Kempthorne has said. "However, if we can better prepare Americans to plan for their health needs in retirement, change the focus of long-term care from institutional-based services to home and community-based services, and assist individuals in following healthier lifestyles, we can help citizens age with independence and dignity."

Missouri Governor Bob Holden has launched a new program that will forgive up to \$10,000 in student loans for students who pursue a math or science degree and take a job with a life sciences company based in the state.

The program is called the Missouri Advantage Repayment Incentive Option, and offers up to \$2500 in loan forgiveness every year for up to four years that a student is employed at an eligible company. Funding comes from interest on a protion of tax-exempt bonds allocated to the state's Higher Education Loan Authority.
